##### *WNCC Women's Basketball Coach David Harnish*

WNCC women's basketball coach Dave Harnish knows only one word when it comes to basketball -- winning. Harnish has definitely found that the case at WNCC.

In Harnish's 21 years as women's basketball coach, he has compiled over 500 wins in junior college. He has guided the Lady Cougars to 20-plus wins every year, including six straight 30-win seasons, been to the Region IX championship game 17 years, and finished in the top eight at nationals the past five out of seven seasons. He also helped the team to a No. 1 ranking in the nation three seasons ago.

Harnish has also coached many all-Americans and has sent many players on to Division I and high Division II schools to continue playing.

##### *WNCC Women's Basketball Assistant Jennifer Pedersen*

Assistant coach Jennifer Pedersen has been an assistant coach at WNCC for the past eight years. She is also the Athletic Director in her spare time.

Pedersen, though, is no stranger to WNCC having played at WNCC from 1994-96 helping them to the regional title in 1995. Pedersen also played on the Cougar volleyball team her freshman year and still holds one of the blocking records.

Pedersen graduated from Rawlins, Wyo., High School. After WNCC, she played basketball at Black Hills State University.
